- Asylum applications
- Detention
- Refugee family reunion applications
- Applications for asylum support (if you have applied for housing and financial support)

COMMUNITY CARE

- If you need help or services from the local authority and/or the NHS because of illness, disability or mental capacity (including Court of Protection cases)
- Disputes about the quality of care in residential, nursing homes and hospitals, and abuse/neglect issues

DEBT

- If you might lose your home because of mortgage arrears
- Or a creditor is taking you to court to sell your home
- Or a creditor is making you bankrupt

COUNCIL TAX REDUCTION

 Only for appeals to the Upper Tribunal, High Court, Court of Appeal or Supreme Court

DISCRIMINATION

 If you have been unlawfully discriminated against

CRIME

e.g. being arrested, charged or questioned by the police

EDUCATION

If you disagree with a special educational needs decision about your child

ISSUES

- Family mediation to resolve disputes about children and finance on a relationship breakdown
- Social services being involved with your children
- Injunctions against a violent or abusive partner or family member
- Other family problems if you or your child have suffered or are at risk of violence or abuse
- If your child has been or is about to be taken out of the country without your consent
- Some High Court proceedings about the welfare of your child
- If you have been served with proceedings under the "Hague Convention"

IMMIGRATION

- Applying for indefinite leave to remain after relationship breakdown due to domestic violence or an EU citizen applying to stay after domestic violence
- Applying to stay as a victim of trafficking
- Proceedings before the Special Immigration Appeals Commission (SIAC)
- Terrorism Prevention & Investigation Matters (TPIM) notices
- Bail applications for immigration-related detention

MENTAL HEALTH &

MENTAL CAPACITY

- For representation at mental health tribunals if

- Advice if you have been sectioned, for Court

Deprivation of Liberty Safeguards (DoLS)

of Protection cases and for appeals against

you are detained in hospital

Only for appeals to the Upper

Tribunal, High Court, Court of

Appeal or Supreme Court



MORE ISSUES

- Cases for children with brain (neurological) injuries resulting in severe disability, which arise during pregnancy, childbirth or up to eight weeks postnatal (not all injuries are covered)

- claims about abuse and sexual assault allegations, confiscation proceedings, environmental pollution and cross-border
- from working with children and vulnerable
