# MP surgeries surveys

The Low Commission asked the Young Legal Aid Lawyers (YLAL) to carry out a follow-up study to assess the impact on MPs following the Legal Aid, Sentencing and Punishment of Offenders (LASPO) Act 2012 which came into force on 1 April 2013. To do this, YLAL returned to those MPs who had taken part in YLAL's original survey of 45 MPs and caseworkers across England and Wales, conducted in 2011. YLAL asked them to answer a series of five supplementary questions using an online survey tool. Twenty-nine of the original MPs and caseworkers agreed to take part in the follow-up survey. YLAL have published the results in their report *Nowhere else to turn: one year on* (August 2013).<sup>2</sup>

YLAL stress in the introduction to their survey report that their findings are necessarily just a snapshot and that the survey was only conducted four months after the cuts; they also highlight the various welfare reforms that were taking place in the same period, which could also result in increased demands on MPs' surgeries. The survey involved asking five supplementary questions to get a picture of changes in demand for advice since 1 April 2013.
