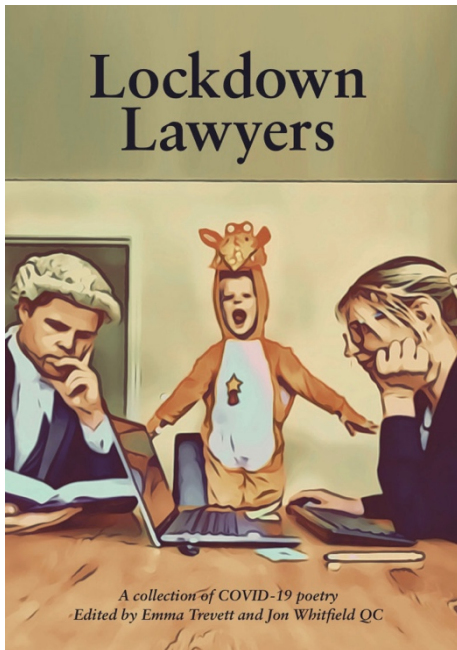


# Lockdown Lawyers

The original brief to writers was simple: write about the lockdown and near collapse of the legal system. How have you coped? Have you coped? How have you continued to support clients?

*Lockdown Lawyers* aims to mark what has been the most unusual and difficult of times and to show how despite the decades of cuts we as a sector have coped. It aims to raise a smile and most importantly, all proceeds from the book will be donated to Law Centres Network to continue their work for the most vulnerable people in society.
