Bahar AtaDuncan Lewis

Bahar is a CILEx fellow and public law director at Duncan Lewis,

running a team of 20 at its Luton office. She specialises in immigration work, including challenging unlawful detention, age assessments, removals and deportations. She acted for a number of clients who were being put on a charter flight to Jamaica in February 2020, in a case that attracted intense media interest. She is described as 'a fearless advocate for human rights'.



Dean Kingham Swain & Co

Dean conducts criminal appeals and public law work in relation

to prisoners' rights, acting for those accused of the most serious offences – murder, extreme violence, serious sexual assault and terrorism – whose cases attract little public sympathy. James was counsel for the successful appellant in last year's Supreme Court case of Samuels v Birmingham City Council, which has been hailed as a landmark victory for tenants whose housing benefit doesn't cover their rent. James fought 'valiantly and bravely' for Terryann Samuels and is described by one supporter as 'truly a Superbarrister'.

Duncan Lewis Public Law Team (Harrow)



High-profile interventions in the last year include *K*, in the Court of Appeal, which challenged an antiquated element of British nationality law affecting who is deemed to be a child's father, when it operates to that child's detriment. Arfan became Oliver Fisher's lead solicitor for its Grenfell Tower clients when he was just two years' qualified, representing survivors and bereaved families at the inquiry into the disaster. A barrister working with him says he is 'strikingly calm and patient', even in the

most difficult circumstances, and 'creative and ambitious' in his determination to secure the best result for his often vulnerable and distressed clients.



Miranda ButlerGarden Court Chambers

Miranda has a broad public law practice, focusing on immigration, asylum and nationality law, and has built particular expertise in trafficking and unlawful detention cases. She was called to the bar in 2013 and has worked on a string of strategic challenges, including

to the Home Office over fees charged to children entitled to register as British citizens. She is described as having 'strength and depth', being accessible and a team player.



Daniel Cooper Imran Khan & Partners

Daniel qualified in June 2019 and has achieved remarkable successes for his firm's public law department. While a trainee, he acted at a three-week jury inquest into the deaths of five men killed when a wall collapsed at a recycling plant. He is representing

60 abuse survivors in the Lambeth Children's Homes Redress Scheme. Imran Khan QC says Daniel has shown 'extraordinary ability' to deal with emotionally and intellectually demanding cases.



Siobhan Taylor-Ward Merseyside Law Centre

Siobhan is a dedicated social welfare lawyer and tireless campaigner for justice. She qualified this year and is praised for her immense contribution to 'the reinvigoration of specialist social welfare legal advice in Merseyside'. She is a Justice First Fellow and former

national vice-chair of Young Legal Aid Lawyers, leading on its work promoting social mobility and diversity. A former colleague says she is 'a fantastic fighter for clients' rights'.

Martin Bridger InstaLaw Solicitors

Martin works with young, unaccompanied asylumseekers and has played a key role securing greater protections for these vulnerable children. His landmark cases in the last year include *AB v Kent*, which challenged the practice of conducting 'visual age

assessments' of unaccompanied child migrants at police stations, and TN v Secretary of State for the Home Department, which established that the Home Office has strict liability when wrongly detaining a child whom it had believed to be an adult.



Hazel Montgomery Cartwright King

Hazel is a former criminal defence solicitor who now specialises in mental health work. Her nomination is supported by a range of medical professionals, including a consultant psychiatrist who says she makes

a 'formidable adversary' at tribunals, adding that she fights 'the patient's corner to the nth degree'. Another says she has a gift for putting patients with complex needs and communication difficulties at their ease.



Simon Mullings Edwards Duthie Shamash

Simon is a housing caseworker with more than 20 years' experience at the legal aid coalface, who has also acted in cases that have gone to the Court of Appeal. He is described as having all the qualities anyone would want to find in a legal aid lawyer: 'compassion,

resilience, a brilliant mind, and a determination to achieve the very best for his clients'. He is also praised for his commitment to campaigning for access to justice.



Mike Norman Bristol Law Centre

Mike is a housing lawyer handling possession proceedings, injunctions, disrepair and unlawful evictions. Many of his clients are intensely vulnerable: victims of trafficking and domestic violence, and with enduring mental health problems. One barrister says:

'He is a true expert in housing law in the dual jurisdictions of England and Wales.' Another adds: 'He is the most passionate and dedicated solicitor I have ever worked with.'

Belfastbased KRW is known for its ground-

breaking work on conflict-related legacy litigation, covering complex, multi-death inquests, judicial review and claims against public authorities. It secured an amendment to Legal Aid Agency regulations to allow it to act for families at the resumed inquest into the 1974 Birmingham pub bombings, and is acting at the resumed inquest into the Guildford pub bombings, due to start in 2021 thanks to its efforts.



Turpin Miller

Turpin Miller provides legal aid housing, debt and immigration

advice across a wide geographical area, stretching from Reading through west Berkshire and Oxfordshire. One supporter from a housing support agency says they are 'literal lifesavers'. A worker at a homelessness charity says: 'They understand the needs and vulnerabilities our clients face and are able to communicate the legislation in a way that is understandable to all.'



Ison Harrison (incorporating Harrison Bundey)

Describing itself as 'the

Yorkshire law firm', Ison Harrison has a string of offices across the county and beyond, providing legal aid services in family, clinical negligence, criminal defence, immigration and public law. Among the leading lights in its publiclyfunded work is the legendary Leedsbased Ruth Bundey, who has spent four decades building an unmatched reputation as a specialist in inquest law.
